

AN ACT to amend the Railway Management 1931. Act, 1891, and certain other Acts, and to repeal the Cattle Guards Act, 1884. [4 November, 1931.]

**B**E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :---

Amendment of 1 Geo. V. No. 11. 2 The Railway Management Act, 1891, is hereby amended by inserting after Section Thirty-three the following new Section 33a:—

"**33a** In any case where any line of railway has been closed under this Act, the Minister may grant to any person a licence to use such railway or any part thereof, upon such terms and subject to such conditions as may be arranged between the parties and as shall be approved by the Governor.".

**3** Section Four of the Railway Management Act, 1927, is hereby amended—

I. By inserting after Subsection (1) the following new Subsection (1A) :--

"(1A) Any such sale as aforesaid may include the grant of any right-of-way or other easement over any land used or required for railway purposes.": and

II. By adding at the end of Subsection (2) the words ", and to grant to such purchaser any such easement as aforesaid".

**4**—(1) The Cattle Guards Act, 1884, is hereby repealed.

(2) Any reference in any Act to the Cattle Guards Act, 1884, shall cease to have effect upon the commencement of this Act.

5 The Railway Clauses Consolidation Act, 1901, is hereby amended by expunging the proviso to Subsection (2) of Section Twenty-four thereof.

6 The Lands Resumption Act, 1910, is hereby amended by deleting the sixth and seventh lines of Section Twenty-nine thereof.
