

AN ACT relating to a certain Sum of Money A.D. 1927.
 advanced by the Governor to the Rural
 Municipality of Ross to defray the cost
 of providing Buildings for Police Purposes
 in the Town of Ross. [8 September, 1927.]

WHEREAS the Governor, under the authority of the Act of Par- Preamble.
 liament 60 *Victoria* No. 26, granted a loan of Three hundred Pounds
 to the Municipal Council of the Rural Municipality of Ross (herein-
 after called "the said Municipality") under the provisions of the 54 Vict. No. 30.
 Local Public Works Loans Act, 1890, for the purpose of defraying the
 cost of providing buildings for police purposes in the Town of Ross,
 and the said sum was advanced by the Treasurer to the said Council
 and expended by the said Council in the provision of such buildings
 as aforesaid :

And whereas under and by virtue of the Police Regulation Act, 62 Vict. No. 48.
 1898, the Minister administering that Act agreed with the said Council
 for the purchase by the Minister from the Council of the said buildings
 and the land on which the same were erected for the sum of Three
 hundred Pounds, and the said land and buildings were subsequently
 surrendered by the said Municipality to the Crown :

Ross Municipality Loan (Police Buildings).

And whereas no payment was made by the Minister to the said Council in respect of such purchase money aforesaid; but the amount of the principal money owing by the said Council to the Treasurer in respect of the aforesaid loan was set off against such purchase money, all interest and other charges in respect of such loan having been duly paid by the said Council to the Treasurer:

And whereas it is expedient to ratify such set-off as aforesaid, and to make provision for the adjustment of the accounts in the Treasury books in connection with the transactions hereinbefore referred to:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title.

1 This Act may be cited as “The Ross Municipality Loan (Police Buildings) Act, 1927.”

Interpretation

2 In this Act, unless the context otherwise indicates or requires—
 “The said Council” means the Council of the Rural Municipality of Ross:
 “The said loan” means the loan granted by the Governor to the said Council as set out in the Preamble:
 “The said Minister” means the Minister who, at the time of the purchase of the police buildings referred to in the Preamble, was administering the Police Regulation Act, 1898:
 “The Preamble” means the Preamble to this Act.

Ratification of set-off of loan moneys against purchase money of police buildings.

3 It shall be deemed to have been lawful for the Treasurer to have set-off the principal money owing by the said Council to the Treasurer in respect of the said loan against the purchase money agreed to be paid by the said Minister to the Council for the land and buildings referred to in the Preamble.

Provisions in connection with adjustment of Treasury books.

4 For the purpose of making the necessary adjustments in the accounts in the Treasury books in connection with the transactions referred to in the Preamble, the said Council shall be deemed to have repaid to the Treasurer the amount of the said loan, and the Treasurer shall be deemed to have been authorised to apply, and to have applied, the said amount in payment of the purchase money agreed to be paid by the said Minister to the Council for the land and buildings referred to in the Preamble.
