AN ACT to amend the Stamp Duties Act, 1931. [10 January, 1934.]

A.D. 1933.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as "The Stamp Duties Act, 1933."

Short title.

2 The Principal Act is hereby amended—

I. By inserting after the word "instrument" at the Section 9. end of Subsection (1) of Section Nine the words "but where any instrument is executed by more than one person and a collector is satisfied that

delay in stamping such instrument has occurred in good faith owing to any reasonable difficulty in obtaining the execution of any necessary party thereto, within the period hereinbefore prescribed, he may stamp, or sufficiently stamp, such instrument, as the case may require, without penalty.":



- VI. By inserting after the word "instruments" in the Schedule A.D.1933. seventh line of Paragraph I. of Rule 5 in Schedule (4).

 (4) the words "but, if the duty so payable exceeds the ad valorem duty, the latter shall be payable thereon."
- 3 Section Eleven of the Principal Act is amended by adding at the end thereof the following Subsection (3):—
- "(3) When duty has once been paid on any ticket, no further duty shall be payable in respect of any share in, or portion of, such ticket into which the same may be divided."
