

AN ACT to further amend the St. Leonards Water Act, 1914. [29 November, 1927.]

A.D. 1927.

WHEREAS it is expedient to further amend the St. Leonards Water Act, 1914.: PREAMBLE.

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as "The St. Leonards Water Amendment Act, 1927." Short title.

**2** In this Act the expression "the said Act" means the St. Leonards Water Act, 1914.

**3** Section Three of the St. Leonards Water Act, 1914, is amended by deleting all the words following the words "Description of Water District" and substituting in lieu thereof the following words —

"Commencing at a point on the Main-road to Hobart at its junction with a by-road near the top of Sandhill (now known as Peel-street) thence in a north-easterly direction twenty chains along the north-western boundary of three hundred and forty-nine acres originally granted to *Alexander Waddle* thence by an imaginary line parallel with the Main-road and twenty chains distant from it (through lands granted to *P. Oakden W. T. Bell* and others) to a point on seventy-three acres granted to *T. Archer* distant twenty chains from the Main-road and twenty chains distant in a northerly direction from the road leading to Relbia Railway-station thence by an imaginary line parallel with the last mentioned road and distant from it twenty chains (passing through land granted to *R. J. Parker* and others) to the Main Line Railway thence by that railway to a point on the railway distant twenty chains south-easterly from Relbia Station thence by an imaginary line parallel with the Relbia Station-road (and distant therefrom twenty chains) passing through lands granted to *J. Solomon Sir J. G. L. Innes R. J. Parker* and others crossing the Main-road to a point on land belonging to *H. Lewis* twenty chains from the Main-road then by an imaginary line running in a general north-westerly direction and parallel with the Main-road and distant therefrom twenty chains to a point on the north-western boundary of two hundred and forty-nine acres three roods twenty-four perches originally granted to *Alexander Waddle* and thence along that boundary twenty chains north-easterly to the point of commencement."

**4** This Act and the said Act, and every other act amending the said Act, shall be read and construed together as one Act.
