AN ACT to amend the Tasmanian State Service (Transitional Provisions) Act 1984.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Tasmanian State Service (Transitional Provisions) Amendment Act 1985*. Short title.

2—This Act shall commence on the day fixed under section 2 (2) of the *Tasmanian State Service (Transitional Provisions) Act 1984*.

3—Schedule 1 to the *Tasmanian State Service (Transitional Provisions) Act 1984** is amended as follows:—

- (a) by omitting clause 5;
- (b) by inserting in clause 26 after subclause (2) the following subclause:—

(3) Where, in the determination of an application in respect of a review of any salary determination pending under section 67 of the *Public Service Act 1973* at the commencement of section 66 of the Principal Act, the Commissioner for Review directs the Head of an Agency to vary the classification of a position held by an employee, section 33 (4) of the Principal Act shall not apply.

- (c) by omitting paragraphs (d) and (e) from subclause (2) of clause 28 and substituting the following paragraph:—

(d) Director of Racing.

- (d) by inserting after paragraph (g) of subclause (4) of clause 29 the following paragraph:—

(ga) a person employed under section 32B of that Act as in force immediately before that day;

- (e) by inserting after paragraph (b) of that subclause the following paragraph:—

(ha) a person employed under section 46H of that Act as in force immediately before that day;

- (f) by inserting after paragraph (x) of that subclause the following paragraph:—

(xa) a person appointed under section 9 of the *Hobart Regional Water Act 1984* as in force immediately before that day;

- (g) by inserting after paragraph (z) of that subclause the following paragraph:—

(zaa) a person who by the operation of an agreement under section 18 of the *Libraries Act 1943* became employed by the Tasmanian Library Board before that day;

- (b) by omitting paragraph (zf) of that subclause;

(i) by omitting paragraph (zl) of that subclause and substituting the following paragraph:—

(zl) a person appointed by the Minister under the *Northern Casino Act 1978* as in force immediately before that day;

(j) by inserting after paragraph (zo) of that subclause the following paragraph:—

(zoa) a person appointed and employed under section 11A of the *Racing Act 1983* as in force immediately before that day;

(k) by inserting “*Service*” after “*Therapy*” in paragraph (zp) of that subclause;

(l) by inserting after paragraph (zp) of that subclause the following paragraph:—

(zpa) a person appointed under section 3A of that Act as in force immediately before that day;

(m) by omitting paragraph (zu) of that subclause;

(n) by inserting after the item relating to the Secretary to the Chiropractors Registration Board in the Table to clause 31 the following item:—

(o) by omitting “section 7 (13)” from the item relating to the Secretary of the Environment Protection Advisory Council in that Table and substituting “section 7A”;

(p) by omitting from that Table the item relating to the Secretary of an Industrial Board and the item relating to the Registrar of the Industrial Appeals Tribunal;

(q) by omitting from that Table the item relating to the Registrar of the Restricted Publications Board;

(r) by omitting from that Table the item relating to the Registrar of Trade Unions.
