AN ACT to provide for the Execution of cer- 1930. tain Works in connection with the Provision

by the State of Accommodation Houses for [23 December, 1930.] Tourists.

HE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as "The State Tourists Accom- Short title. modation Houses Execution Act, 1930."

2 It shall be lawful for the Minister to cause to be executed Power to Minand carried out the works specified in Schedule (1) to this Act, ister to carry at a cost not exceeding the amount set forth in the schedule out works. in respect thereof.

State Tourists Accommodation Houses Execution.

A.D. 1930.

Power to Treasurer to reappropriate £262 18s. 11d. and to borrow £287 1s. 1d.

- **3**—(1) The cost of executing and carrying out the works authorised by this Act shall be defrayed—
  - I. As to the sum of Two hundred and sixty-two Pounds Eighteen Shillings and Elevenpence, by the expenditure of the aggregate of the sums specified in Schedule (2) to this Act, being the unexpended balances of the amounts appropriated for the items mentioned in that schedule: and
  - II. As to the balance thereof, out of moneys provided by this Act.
  - (2) It shall be lawful for the Treasurer—
    - I. To reappropriate the several sums specified in Schedule (2): and
    - II. To raise, borrow, and receive any sum or sums of money not exceeding in the aggregate the sum of Two hundred and Eighty-seven Pounds One Shilling and One Penny—

for the purposes of this Act.

**4** The provisions of the Public Works Construction Act, 1880, shall extend and apply to the works mentioned in the schedule as fully in all respects as if they were incorporated in this Act.
