

AN ACT to amend "The Scottsdale Water [21 December, 1921.] Act, 1895."

WHEREAS the Warden, Councillors, and Electors of the Munici- PREAMBLE. pality of Scottsdale desire to borrow under the provisions of "The State Loans to Local Bodies Act, 1921," a further sum not exceeding Six hundred and fifty Pounds, for the purposes of "The Scottsdale Water Act, 1895":

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled as follows :---

1-(1) This Act may be cited as "The Scottsdale Water Act, Short title. 1921."

(2) "The Scottsdale Water Act, 1895," is herein called "The Principal Act, 59 Vict. No. 55. Principal Act."

2-(1) Subject to the passing of a special resolution for that purpose before or after the passing of this Act in pursuance of the pro-

visions of "The Local Government Act, 1906," it shall be lawful for

the Council, on behalf of the Corporation. to borrow under the pro-

visions of "The State Loans to Local Bodies Act, 1921," any sum or

sums of money, not exceeding in the whole the sum of Six hundred and

fifty Pounds, in addition to any amounts previously borrowed under

any Act or Acts, for the purpose of carrying out the objects of the

Principal Act, it shall not be necessary for the Council to take any

further poll as provided by that section before applying or expending

any moneys borrowed under this Act for any of the purposes aforesaid.

3 The amount payable by the Council as an annual contribution towards a sinking fund in respect of any moneys borrowed under this Act, shall be a sum equal to One Pound per centum of the moneys so borrowed.
