ACT to further amend "The Town A.D. 1889. [9 November, 1889.] Boards Act, 1884."

WHEREAS doubts have arisen whether certain Town Boards PREAMBLE. which have been elected under the provisions of "The Town Boards 48 Vict. No. 30. Act, 1884," and the Acts incorporated therewith, have been duly elected, and it is expedient to remove such doubts, and to amend the said Act in certain particulars:

Be it therefore enacted by His Exdellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 Whereas Proclamations have been issued for the election of a Proclamation Board for the Town of *Ulverstone*, but no Board has been duly conmay issue for stituted for the said Town, and it is expedient to authorise the issue election of Board for *Ulverstone*. of a further Proclamation for the election of a Board for the said Town: Be it therefore enacted, that it shall be lawful for the Governor in Council, notwithstanding the provisions of Section Four of the said Act, to issue a Proclamation directing that, at a time and place therein named, there shall be held within the said Town a meeting of the Electors for the purpose of electing from amongst such Electors either Three or Five persons, as fixed by such Proclamation, as and to be the Board of such Town for the purposes of this Act; and such election shall be held accordingly. And for the purposes of such election all the provisions of "The Rural Voting Act 1884," shall be applicable to the election of Members of a Board under this Act.

Town Boards Amendment.

A.D. 1889.

Election of present Boards validated.

2 Every other Town Board and every Member thereof elected before the commencement of this Act, shall be deemed and taken to have been duly and validly elected such Board and Members thereof respectively under the said Act and the Acts incorporated therewith, to and for all intents and purposes whatsoever.

Proclamation to appoint person to hold election.

3 Any Proclamation issued under this Act, and every Proclamation issued under the said Act, shall appoint that any election held thereunder shall be held before such person as shall be appointed therein and thereby; and nominations of persons for election as Members of the Board shall be forwarded to and be received by such person Seven clear days before the day appointed for holding the election pursuant to such Proclamation, and such person shall thereupon provide and do all things necessary for holding such election pursuant to the said Act and this Act.

Member of Boards elected in same manner as Trustees of Road Districts. 48 Vict. No. 28. 4 Every election of a Town Board or any member thereof shall be held, conducted, and completed in all respects in the same manner as elections of a Trustee or Trustees of a Road District are held, conducted, and completed; and all the provisions of "The Roads Act, 1884," and every amendment thereof, relating to the election of Trustees, shall be applicable to the election of Members of a Town Board.

Mode of nomination.

5 Every nomination of any person for election shall be the same in all respects as nominations of persons for election as Trustees of a Road District.

Amendment of Section 6 of 48 Vict. No. 30. 6 The words "except Section Fifty-eight of the said Act" in Section Six of "The Town Boards Act, 1884" are hereby repealed, and the said Section shall be read and construed as if the said words had always been omitted from the said Section.

Short title.

7 This Act may be cited for all purposes as "The Town Boards Amendment Act, 1889."

Acts to be read together.

8 This Act and "The Town Boards Act, 1884," and the Acts amending the same, shall, save as amended by this Act, be read and construed together as one Act.
