AN ACT to amend the Tasmanian Trotting Control Board Act 1976.
[Royal Assent 11 January 1984]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Tasmanian Trotting Control Board Amendment Act 1983*. Short title.

2—This Act shall commence on 13th February 1984.

Principal Act. **3**—In this Act, the *Tasmanian Trotting Control Board Act 1976** is referred to as the Principal Act.

Amendment of long title to Principal Act. **4**—The long title to the Principal Act is amended by omitting “trotting control” and substituting “harness racing”.

Amendment of section 1 of Principal Act (Short title). **5**—Section 1 of the Principal Act is amended by omitting from subsection (1) “*Trotting Control*” and substituting “*Harness Racing*”.

Amendment of section 3 of Principal Act (Interpretation). **6**—Section 3 of the Principal Act is amended as follows:—

(a) by omitting “Trotting Control” from the definition of “Board” and substituting “Harness Racing”;

(b) by inserting the following definition after the definition of “Board”:—

“harness racing club” means a club that is registered under the *Racing and Gaming Act 1952* for the purpose of conducting harness racing;

(c) by omitting “Act;” from the definition of “Rules of Trotting” and substituting “Act.”;

(d) by omitting the definition of “trotting club”.

Repeal of section 14 of Principal Act (Officers of the Board). **7**—Section 14 of the Principal Act is repealed.

Savings provision. **8**—A person appointed as a member of the Board under section 4 (1) (b) of the Principal Act, as in force before the commencement of the *Tasmanian Trotting Control Board Amendment Act 1983*, who holds office as such a member immediately before that commencement shall be deemed to hold office under the Principal Act, as amended by this Act, and he shall, unless he sooner vacates his office pursuant to section 13 of the Principal Act, hold office for the remainder of the period specified in his instrument of appointment under that Act.

Consequential amendments. **9**—The Principal Act is amended in the manner specified in Schedule 1.
