

TASMANIAN UNIVERSITY.

No. 10 of 1963.

AN ACT to amend the *Tasmanian University Act* 1951. [2 May 1963.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Tasmanian University Act* 1963. Short title and citation.

(2) The *Tasmanian University Act* 1951, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section eleven of the Principal Act is amended—

Vesting and control of certain land.

- (a) by omitting from subsection (1) thereof the words “land described in the second schedule (in this section referred to as ‘the said land’) is” and substituting therefor the words “lands respectively described in Parts I and II of the second schedule (in this section referred to as ‘the said lands’) are”;
- (b) by omitting from subsection (2) thereof the word “land” (first occurring) and substituting therefor the word “lands”, and by omitting from that subsection the words “if the said land” and substituting therefor the words “if any part of the said lands”;
- (c) by omitting from subsection (2A) thereof the word “land” (first occurring) and substituting therefor the word “lands”; and
- (d) by omitting from subsection (3) thereof the word “land” (wherever occurring) and substituting therefor, in each case, the word “lands”.

3 The second schedule to the Principal Act is amended—

The second schedule.

- (a) by inserting therein, after the words “(Section 11.)” the following heading:—

“PART I”; and

- (b) by adding at the end thereof the following Part:—

" PART II.

" 1R 16 8/10P.

" Commencing at a point distant 6 feet 7½ inches westerly from the southern angle of Lot 90 on Nelson Road shown on survey 339/1 deposited in the office of the Recorder of Titles and bounded on the south-east east and north-east by 132 feet 2¼ inches south-westerly southerly and south-easterly in several bearings along Nelson Road aforesaid on the south-west by 149 feet 10½ inches north-westerly along Lot 1 owned by J. H. Gleeson on the north-west by 142 feet north-easterly along a footpath 12 feet wide and thence on the north-east by 129 feet 8¼ inches south-easterly along a footpath 6 feet wide to the point of commencement as the same is shown on Survey Diagram Volume 318 Folio 15 filed and registered in the office of the Surveyor-General and Secretary for Lands at Hobart."
