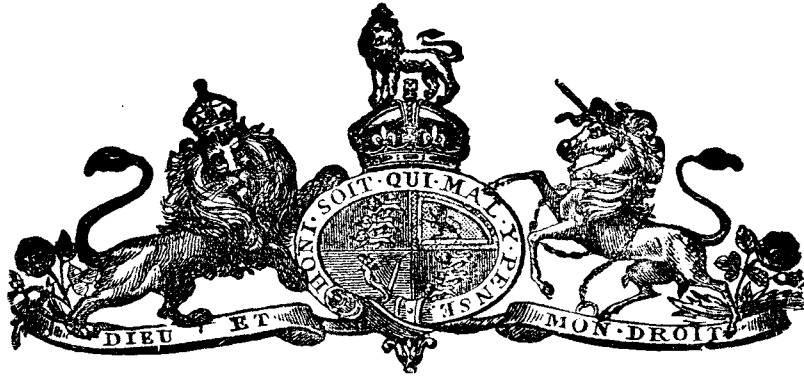

AN ACT to amend the Workers' Compensation Act, 1927. [18 January, 1930.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as "The Workers' Compensation Act, 1929."

**2** The Workers' Compensation Act, 1927, is hereby amended—

- I. By deleting the word "five" in the Fourth line of Paragraph i. of Subsection (3) of Section Four thereof, and substituting therefor the word "six":
- II. By inserting after the word "payment" in the third line of Subsection (1) of Section Twenty-seven the words:—  
"or in a lump sum as provided by Rule 2 in the schedule":
- III. By expunging Paragraph v. of Subsection (1) of Section Thirty-six, and substituting therefor the following new Paragraphs v. and va.:—

v. The manner in which, and the times at which, any moneys shall be—

- (a) Paid by, or to, the Public Trustee; and
- (b) Invested or applied by the Public Trustee—

under this Act; and the fees and commission, if any, to be charged by the Public Trustee in any case, or class of cases, in relation thereto; and the cases in which applications may be made by the Public Trustee to a judge on behalf of any party interested in any such moneys; and the cases in which any such moneys may be applied as may be agreed between the parties interested therein":

va. The manner in which, and the conditions under which, moneys payable—

- (a) Under this Act, to or for the benefit of any person who resides, or who is about to reside, in any other part of His Majesty's dominions may be transmitted to the appropriate authority in such part of such dominions; and
- (b) Under provisions of similar intent to the provisions of this Act, in force in any such part of such dominions, to or for the benefit of any person who resides, or is about to reside, in this State, may be received by the Public Trustee—

for the purpose of being administered and applied by such authority, or by the Public Trustee, as the case may be, for the benefit of such person; and the provisions of any regulation hereunder made shall apply in respect of every part of His Majesty's dominions with which the Governor shall have entered into arrangements for the reciprocal application of such provisions.":

- IV. By inserting after the figure (1) at the beginning of Rule Schedule. A.D. 1929  
2 of the schedule the words:—  
“Except as provided in division (5) of this Rule”: Rule 2 (1).
- V. By deleting from the first line of Paragraph III. of division Rule 2 (2)  
(2) of Rule 2 aforesaid the words “Two Pounds Fifteen III.  
Shillings” and substituting therefor the words “Three —  
Pounds”:
- VI. By inserting after the word “accident” in the third line of Rule 2 (3)  
Subdivision (a) of Paragraph 1. of division (3) of Rule 1. (a).  
2 aforesaid the words:—  
“or during the period of employment with his then em-  
ployer if such period is less than twelve months”:
- VII. As to division (5) of Rule 2 aforesaid:— Rule 2 (5).  
(a) By deleting therefrom all the words from and  
including the word “such” in the second line  
down to and including the word “injured” in  
the third line thereof and substituting therefor  
the words:—  
“a lump sum payment which is such percent-  
age of the maximum amount of compen-  
sation payable under this Act”:
- (b) By deleting from the first line of Paragraph 1.  
thereof the words “highest rate” and substituting  
therefor the word “maximum”: and
- VIII. By deleting from the heading to the second column of Divi- Division  
sion IV. of the schedule the words “highest rate of” and IV.  
substituting therefor the word “maximum.”

**3** The receipt of any person under the age of twenty-one years to whom any money is payable by way of compensation or otherwise under this Act shall be a good and valid discharge for the payment thereof, notwithstanding that such person is a minor.

Payments to minors.

**4** The Governor from time to time may make arrangements with the competent authority in any other part of His Majesty's dominions for the transmission of moneys—

i. From this State to: and

ii To this State from—

such other part of such dominions and for the administration and application of such moneys in such part of such dominions or in this State, as the case may be, for the benefit of the persons entitled thereto.
