

AN ACT to ratify and confirm a certain 1926. Guarantee, given by the Premier to the Minister of State for Trade and Customs for the Commonwealth, with respect to the Payment of the Cost of Wire-netting supplied to the Settlers in the State.

[17 September, 1926.]

W HEREAS the Minister for Lands and Works of the State has PREAMBLE. received from the Minister of State for Trade and Customs for the Commonwealth the sum of Four thousand four hundred and thirty-four Pounds Thirteen Shillings and Sixpence, for the purchase of wirenetting to be supplied to settlers in the State, in accordance with the provisions of the Advances to Settlers Act, 1923, of the Commonwealth, and such said sum has been placed to the credit of a suspense account in the books of the Treasury :

#### Wire-netting (Commonwealth) Guarantee.

And whereas the State Minister has, out of the beforementioned sum, expended the sum of Four thousand three hundred and fifty-four Pounds Six Shillings in the purchase of wire-netting, and has, on behalf of the Commonwealth Minister, supplied such wire-netting to various settlers in the State upon certain terms and conditions prescribed by the Commonwealth Act beforementioned, such conditions including a condition for payment to the State Minister, on behalf of the Commonwealth Minister, of the cost of such wire-netting by instalments extending over a period of twenty years:

And whereas the Premier on behalf of the State has guaranteed the payment to the Commonwealth Minister, by the several settlers aforesaid, of the cost of the wire-netting respectively supplied to them as aforesaid, the total amount of such cost being the sum of Four thousand three hundred and fifty-four Pounds Six Shillings beforementioned :

And whereas it is expedient to ratify and confirm the guarantee given by the Premier as aforesaid to the Commonwealth Minister, and to provide for the payment by the Treasurer to the Commonwealth Minister of any sum or sums which the State may be lawfully called upon to pay under or in pursuance of the said guarantee:

BE it therefor enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :--

Short title.

Interpretation.

**1** This Act may be cited as "The Wire netting (Commonwealth) Guarantee Act, 1926."

- **2** In this Act—
  - "The Commonwealth Minister" means the Minister of State for Trade and Customs for the Commonwealth:
  - "The State Minister" means the Minister for Lands and Works for the State:
  - "The said Guarantee" means the guarantee given by the Premier to the Commonwealth Minister referred to in the Preamble to this Act.

Ratification of guarantee.

 $\mathbf{3}$ -(1) It shall be deemed to have been lawful for the Premier on behalf of the State to have given the said guarantee to the Common wealth Minister.

4 It shall be lawful for the Treasurer to pay to the Commonwealth

Minister, out of any moneys to be provided by Parliament for that pur-

pose out of the Consolidated Revenue, any sum or sums of money which the State shall be lawfully called upon to pay to the Common-

(2) The said guarantee is hereby ratified and confirmed.

wealth Minister under or in pursuance of the said guarantee.

Treasurer may day moneys under guarantee.
