AN ACT to amend the Water Act 1957.

[Royal Assent 1 November 1985]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—This Act may be cited as the Water Amendment Act (No. 2) Short title. 1985.
- **2**—This Act shall commence on the day fixed by proclamation commence under section 2 (2) of the *Groundwater Act* 1985.

Principal Act.

3—In this Act, the Water Act 1957* is referred to as the Principal Act.

Amendment of section 3 of Principal Act (Interpretation).

- 4—Section 3 of the Principal Act is amended as follows:—
 - (a) by inserting after the definition of "Commission" the following definition:—
 - "groundwater" means any water contained in, or occurring in, a geological formation that is capable of yielding to a well;
 - (b) by omitting "back." from the definition of "take" and substituting "back;";
 - (c) by inserting after the definition of "take" the following definition:—
 - "well" means an excavation or borehole that is deeper than 3 metres below the surface of the earth and made or used for the purpose of extracting groundwater, but does not include a storage works where the surface area of the water is more than 100 square metres and the depth of the water is less than 5 metres.

Amendment of section 83 of Principal Act (Water rights of the Commission).

- **5**—Section 83 of the Principal Act is amended by inserting after subsection (2) the following subsection:—
 - (2A) Where, pursuant to a permit or well order in force under the *Groundwater Act* 1985, a person—
 - (a) has taken groundwater; and
 - (b) diverts water into a river or lake,

the Commission may take any such water that is, or is apparently, being so diverted.

Amendment of section 99 of Principal Act (Malicious abstraction of groundwater).

- **6**—Section 99 of the Principal Act is amended as follows:—
 - (a) by omitting "underground water" and substituting "groundwater";
 - (b) by adding at the foot of the section "Penalty: \$1 000.".
