WYNYARD AIRPORT (SPECIAL PROVISIONS) ACT 1982

AN ACT to authorize the Marine Board of Burnie to acquire and operate Wynyard Airport, and for incidental purposes.

[Royal Assent 16 December 1982]

RE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

PART I

PRELIMINARY

- 1—This Act may be cited as the Wynyard Airport (Special Pro- Short title. visions) Act 1982.
- 2—(1) Part I shall commence on the day on which this Act Commencement. receives the royal assent.
 - (2) Part II shall commence as provided in section 4 (4).

- (d) the granting or reserving to the Commonwealth of an irrevocable licence for the Commonwealth and its officers, employees, contractors, and agents to occupy and use all buildings, structures, and facilities at or used in connection with the airport which relate to the performance or exercise of the functions and powers referred to in paragraph (c) and to have free and unrestricted access to and egress from those buildings, structures, and facilities at all times;
- (e) providing for the security of the airport;
- (f) the satisfaction and performance of any outstanding liabilities and obligations of the Commonwealth incurred by the Commonwealth in relation to the airport before the transfer of the airport to the Board in accordance with the agreement; and
- (g) the transfer to the Board of persons employed by the Commonwealth for the purposes of or in connection with the operation of the airport and the preservation of accrued rights of service to which those persons would have been entitled if they had continued to be employed by the Commonwealth.
- (3) Subject to this Act and with the prior approval of the Minister, an agreement under this section may be varied by the parties to the agreement.
- (4) When an agreement is entered into under this section, the Minister shall cause to be published in the Gazette a notice specifying the date on which the airport was or is to be transferred to the Board in accordance with the agreement, and on and from that date the provisions of Part II shall have effect.

PART II

Special Functions and Powers of Board in Relation to AIRPORT

5—In this Part, a reference to "the agreement" is a reference Interpretation: to an agreement entered into under section 4 and, if that agreement is varied under that section, is a reference to the agreement as so varied.

General functions and powers of Board in relation to airport.

- **6**—(1) Subject to the provisions of this Part and of the agreement, the Board shall have and perform the functions of managing, operating, and maintaining the Wynyard Airport as an airport for the benefit of the public and it shall be the responsibility of the Board to ensure that the airport and the vehicles, plant, equipment, and other articles provided for use at or in connection with the airport are kept in good repair and working order.
 - (2) The Board may-
 - (a) provide and maintain services, facilities, and conveniences for the use or benefit of persons making use of, or resorting to, the airport;
 - (b) sell or let on hire to, or otherwise provide for the use of, those persons, goods, and other articles and things;
 - (c) carry out works for the improvement or alteration of the airport or any part of it, or of any services, facilities, or conveniences provided at the airport or in connection with the operation of it; and
 - (d) purchase or otherwise acquire vehicles, plant, equipment, and other articles for use in connection with the airport,

and may make arrangements with any other person for the doing of any of the things referred to in this subsection.

- (3) The Board may make and recover charges for the use of the airport or any part of it or any services, facilities, or conveniences provided at the airport.
- (4) The Board may do all things necessary for or in connection with, or as incidental to, the performance of its functions under this Part.
- (5) The generality of subsection (4) shall not be taken to be limited by any other provisions of this Part conferring powers on the Board, but any powers to which that subsection relates shall be exercised subject to the agreement.

By-laws.

- **7**—(1) The Board may make by-laws for the safe and efficient management and operation of the airport and for the more effective performance and exercise of its functions and powers in relation to the airport, and, without limiting the generality of the foregoing, any such by-laws may contain provisions—
 - (a) regulating traffic, whether pedestrian or vehicular, and the provision and use of parking places at the airport;

- (b) providing for the security of the airport and, in particular, prescribing the times, terms, and conditions upon which the public may enter or be in or on the airport; and
- (c) prescribing or limiting the charges that may be made for the use of the airport or any part of it or any service, facility, or convenience provided at the airport;
- (2) Section 199 of the Marine Act 1976 applies in respect of by-laws made under this section in the same way as it applies in respect of by-laws made under section 198 of that Act.
- (3) By-laws made under this section are of no effect unless they are approved by the Minister.
- **8**—(1) The Board may grant a lease of, or a licence to use, any power to grant part of the land comprising the airport or any building or structure, leases, &c. or part of a building or structure, constructed on that land for any purpose that will not interfere with the safe and efficient operation of the airport.

- (2) A lease or licence referred to in subsection (1) may be granted by private treaty, tender, or otherwise for a period not exceeding 5 years at such rent or for such other consideration and subject to such other terms and conditions as the Board may determine, and such a lease or licence may, from time to time, at the discretion of the Board, be renewed for a period not exceeding 5 years on the same terms and conditions, other than terms and conditions as to rent or other consideration which may be varied in the renewed lease or licence.
- 9—With the prior consent in writing of the Secretary of the Disposal of airport land. Department of Aviation of the Commonwealth, but not otherwise, the Board may sell, exchange, transfer, grant an easement over, or otherwise dispose of, land forming part of the airport.

10—The Board may acquire by purchase or otherwise land, or Acquisition an easement over land, for the purpose of the airport or to facilitate land. or render safer or more convenient the use of the airport for the landing or taking off of aircraft.

Finances.

- **11**—(1) The Board shall keep separate accounts of its revenue and expenditure under this Act.
- (2) Division V of Part IX of the *Marine Act* 1976 applies, with the necessary modifications (if any), to and in respect of accounts kept by the Board under subsection (1) in the same way as that Division applies to and in respect of accounts kept by the Board under that Division.
- (3) The revenue received by the Board under this Act shall be applied for the purposes of this Act and shall not be treated as part of the revenues of the Board for the purposes of the *Marine Act* 1976, and the revenues received under that Act shall not be applied or expended for the purposes of this Act.
- (4) The powers of the Board under the *Marine Act* 1976 to borrow money apply to the borrowing of money for the purposes of this Act.

Fees payable to Board for use of airport.

- **12**—(1) In order to enable the Board to meet the costs of operating the Wynyard Airport, the Board may charge such fees, in relation to the use by regular public transport aircraft of the airport or any service or facility provided at the airport, as may be prescribed in the by-laws made and in force under section 7.
- (2) A fee charged by the Board pursuant to subsection (1) in relation to the use by regular public transport aircraft of the airport or any service or facility provided at the airport is payable by the operator of the aircraft and becomes due for payment at the expiration of the period of 14 days after the date on which the aircraft used the airport or the services or facilities provided at the airport.
- (3) If the fee referred to in subsection (2) is not paid before the expiration of the period referred to in that subsection, the fee may be recovered from the operator of the aircraft referred to in that subsection in a court of competent jurisdiction as a debt due to the Board.
- (4) In this section, "regular public transport aircraft" means an aircraft classified as such in accordance with the Commonwealth Air Navigation Regulations, as amended and in force for the time being.

13—The Board has, and shall be deemed always to have had, Power to power to appoint and engage as an independent contractor, on such arrangements for perform. terms and conditions as may be arranged, any person or group of ance of certain services. persons considered by the Board to be capable of providing services required by the Board in connection with the performance of its functions and the exercise of its powers under this Part.

14—(1) The Board may appoint and employ such persons as Power to it considers necessary to enable it to perform its functions and exer-employ staff. cise its powers under this Part and carry into effect the provisions of the agreement.

(2) Subject to any other Act, and to any award or industrial agreement, whether under the Industrial Relations Act 1975 or the Commonwealth Conciliation and Arbitration Act 1904, governing the terms and conditions of employment of persons appointed under subsection (1) and subject to the agreement in so far as it relates to persons referred to in section 4 (2) (g), persons so appointed may be employed on such terms and conditions as the Board may determine in respect of them from time to time.

15—Nothing in this Act affects the powers of the Commonwealth Saving as to Common. in respect of the matter of air transport referred to the Parliament wealth of the Commonwealth by the Commonwealth Powers (Air Transport) Act 1952, and, without limiting the generality of the foregoing, nothing in this Act or the agreement shall be construed as authorizing the Board to-

- (a) operate an air transport business or an air service for the carriage of passengers or cargo;
- (b) own, lease, or operate aircraft; or
- (c) control the taking off, landing, or flight of aircraft.
