"(2) Until otherwise determined by the Tribunal referred to in subsection (1) of this section, the members of the Committee shall each receive, by way of remuneration for their services as members thereof, a fee for each day on which they attend at a summoned meeting of the Committee at which a quorum is present, and for each day while they are travelling to or from such a meeting, according to the following scale:—

- (a) in a fire district of the fire brigade board and at
- the undertaker's expense; and
- (b) elsewhere of the council and at its expense,

shall, fix proper fire-plugs in the main and other pipes belonging to them, or erect and connect therewith pillar hydrants and stand pipes, at such places as may be most proper and convenient for the supply of water for extinguishing any fire which may break out within the limits of the special Act.".
