# WAR SERVICE LAND SETTLEMENT.

### No. 13 of 1956.

# AN ACT to amend the *War Service Land Settlement Act* 1950.

[16 May 1956.]

**B**<sup>E</sup> it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:---

Short title and citation.

1-(1) This Act may be cited as the War Service Land Settlement Act 1956.

(2) The War Service Land Settlement Act 1950, as subsequently amended, is in this Act referred to as the Principal Act. No. 13.

2 Section ten of the Principal Act is amended by adding at Disposition of lands by the end thereof the following subsection :---Board.

"(9) The Board may, if it is of opinion that to alter the boundaries of any land vested in it would make that land more useful for any purpose of this Act, with consent sell and transfer pieces along the boundaries of the land to adjoining landowners in consideration of the transfer of pieces on the other side of the boundaries or for any other consideration.".

**3** Section forty-nine of the Principal Act is amended by Profit of mitting from subsection (3) the words "date of distribution" and trading and substituting therefor the words "thirtieth day of June ventures. 1955 ".

4 Section fifty-one of the Principal Act is amended by in-Losses. serting after the word "enterprise" the words "up to the thirtieth day of June 1955".

**5** Section fifty-three of the Principal Act is repealed.

**6** After section fifty-four of the Principal Act the following section is inserted in Division II of Part IV:-

"54A—(1) When the State Sinking Fund Commis-Interim dis-sioners hold any uninvested moneys to the credit of the the Fund. Returned Soldiers' Stock Purchases Fund Account they shall so inform the Board and shall pay to the Board all or so much of those uninvested moneys as the Board may forthwith demand.

(2) Out of any moneys received by the Board under subsection (1) of this section or out of any moneys due to the State Sinking Fund Commissioners under subsection (3) of section forty-nine and unpaid, the Board may make payments on account of distributions under section fifty-two in such manner as the Minister and Treasurer approve.

(3) Section fifty-four shall be applied as nearly as possible to payments by the Board under this section.".
