

# LEGISLATIVE ASSEMBLY

Read 1° 28 November 1979

(Brought in by Mr Maclellan and Mr Thompson)

## A BILL

To amend the *Ministry of Transport Act* 1958 to create the Position of Deputy Director of Transport and for other purposes.

BE IT ENACTED by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):

1. (1) This Act may be cited as the *Ministry of Transport (Amendment) Act* 1979. Short title.

(2) In this Act the *Ministry of Transport Act* 1958 is called the Principal Act. Principal Act No. 6322. Amended by Nos. 6672, 7873, 8165, 8353, 8549, 8608, 8873 and 9148.

10 (3) This Act shall come into operation on the day on which it receives the Royal Assent. Commencement.

2. For section 3 (2) of the Principal Act there shall be substituted the following sub-section: Amendment of No. 6322 s. 3 (2).

“(2) The Ministry of Transport shall consist of—

- 15 (a) the Minister of Transport;  
(b) the Director of Transport;

- (c) the Deputy Director of Transport;
- (d) not more than two Assistant Directors of Transport; and
- (e) such officers and employéés as are deemed necessary.”.

3. In sections 4 (1A) and 6A of the Principal Act for the words 5  
“Any Assistant Director” there shall be substituted the words  
“The Deputy Director of Transport and any Assistant Director”.

4. In section 4 sub-sections (2), (2A) and (3) of the Principa 10

5. Section 4 (4) (a) of the Principal Act shall be amended as follows:

- (a) After the words “Director of Transport” (where first 15  
occurring) there shall be inserted the words “or the  
Deputy Director of Transport”;
- (b) After the words “Director of Transport” (where second  
occurring) there shall be inserted the words “and the  
Deputy Director of Transport”.
